

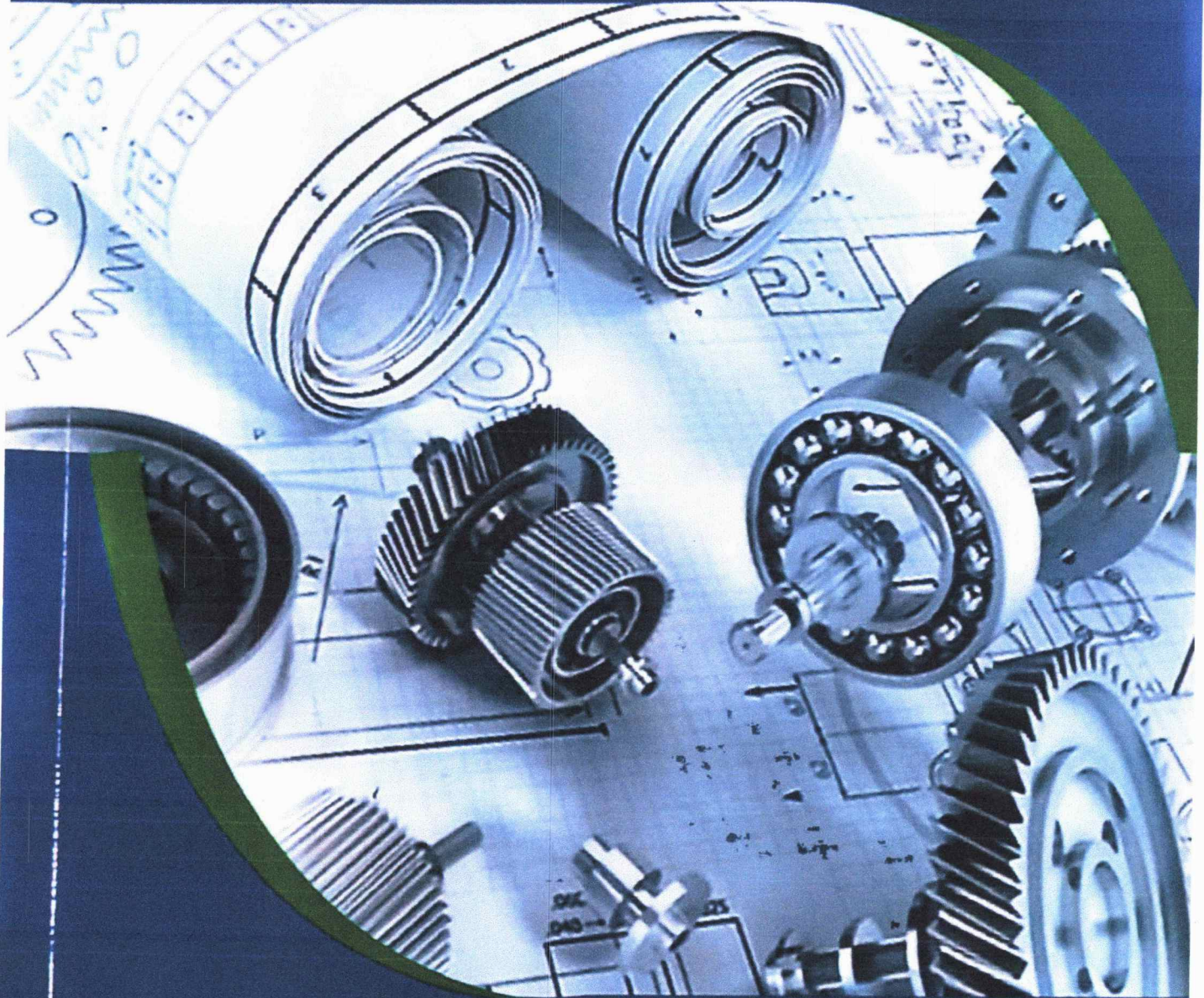

6.9. Students' Grievance Policy

1. To ensure a transparent mechanism for timely redressal of the student grievances, the college appointed grievance redressal committee.
2. The committee consists of faculty members from various departments. This committee deals with all kinds of students' grievances.

Mechanism for Submission of students' grievances:

1. The students are provided with an E-Mail Id to post their complaints on line.
2. Students are given access to the Coordinator of the committee for oral and written complaints.
3. In addition to this, complaints can be dropped in the "Suggestion Box" provided.
4. In case of severe grievance the committee sends it to the notice of principal and Director.
5. Then a special committee is formed to look into the matter and submit the report to the principal.
6. Based on the conclusions and recommendations given by the committee appointed, the action will be taken.

6.10 Anti-Ragging Policy:

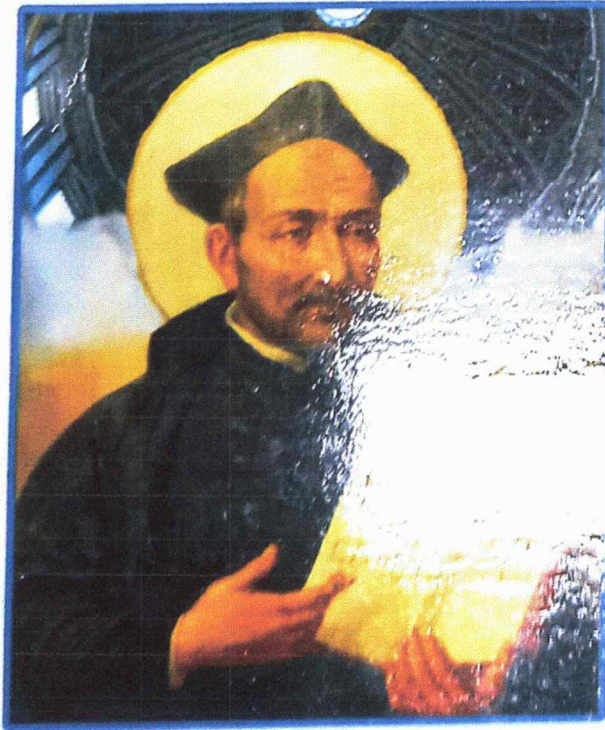
1. Ragging and eve teasing are treated as a serious offense and are strictly prohibited on the campus. The college provides a conducive environment for the learners by keeping a close watch on the behavior of the Students.
2. Anti-Ragging committee with the representatives of faculty members from all the departments has assigned responsibilities to create congenial atmosphere on the campus.

Mechanism Involved :

1. Anti-Ragging squads are constituted comprising of faculty members to make surprise visits to very sensitive location within the campus namely, corridors, canteen, parking lot and out gate in the morning and in the break-time (11.50 a.m-12.45 p.m)
2. The timings of the college for I B.Tech students are changed in order to avoid any kind of ragging on the campus.
3. Anti-Ragging squads supervise the students after the college (4.30pm) at nearby bus stops to avoid ragging
4. For an offence committed in the department or a class room and else where, the institution shall have the authority to reprimand fine or take any other suitable measure.


